The regular scheduled meeting of the Clark County Council was called to order at 5:00 p.m. by Council President David Abbott.

Those in attendance stood for the pledge of allegiance to the American Flag.

Also present were Council Attorney Scott Lewis, County Auditor Keith Groth, Chief Deputy Auditor Vicki Hinkle and Benefits Coordinator Tracy Boettcher.

President Coffman requested proof of Notice to Taxpayers of the additional appropriations listed on the agenda. Scott Lewis, Attorney for the Council stated for the record that publication of Notice of Taxpayers ran in the Evening News ten (10) days prior to this meeting as required by I.C.6-1.11-18-5 and advised the council to proceed.

Councilman Moore made a motion to approve the minutes for the August 9th, 2010 meeting. Councilman Abbott seconded the motion. Carried 6-0.

Amendments to Agenda: Councilman Moore made a motion to add discussion of meeting times to the agenda with a second from Councilman Abbott. Carried 6-0. Councilman Vissing then made a motion to add Borden Inter Local Agreement to the agenda with a second from Councilman Abbott. Carried 6-0. Councilman Moore made a motion to approve the amendments to the agenda with a second from Councilman Abbott. Carried 6-0. Councilman Abbott. Carried 6-0.

Councilmember Moore made a motion to acknowledge the receipt of the Funds Report from the Auditor's office. Councilmember Vissing seconded the motion. Carried 7-0.

First on the agenda was the discussion for the Inter Local Agreement with the Town of Borden. To speak on behalf of the Star Hill Road Project was County Attorney Greg Fifer and the Engineer from Strand. Associates. At this time Councilman Abbott made a motion to approve the Inter Local Agreement with the Town of Borden with a second from Councilman Moore. A roll call vote went as follows:

Next on the agenda was the Town of Covered Bridge with a proposed Inter Local Agreement. Councilman Moore made a motion to approve the Inter Local Agreement contingent upon language change that will allow the Town of Covered Bridge Cagit and Cedit money to go into the County General Fund and the Town's LOIT money to go into the County portion of LOIT. Councilman Abbott seconded the motion. Carried 7-0.

Superior Court1 was next on the agenda with a request for additional appropriations out of Riverboat and LOIT Funds. Councilman Abbott made a motion to table both requests since no one from the court was present. Councilman Vissing seconded the motion. Carried 7-0

Next was County Clerk Barbara Haas with an additional request from the Riverboat Fund and also a Salary Ordinance. Councilperson Hollis made a motion to table the additional request and to also add an additional request be made from the Cum Cap Fund. Councilman Vissing seconded the motion. Carried 7-0. Councilman Vissing then made a motion to approve the Salary Ordinance request with a second from Councilman Moore. Carried 7-0.

The Commissioners were next with a request for additional appropriations for postage for tax bills out of the General Fund, Riverboat Fund and also the Rainy Day Fund. Councilman Smith made a motion to deny the request from the General Fund and the Rainy Day Fund and to approve the request from the Riverboat Fund. Councilman Vissing seconded the motion. Carried 6-1 with Councilman Abbott voting against.

The next item on the agenda was a request from the Building Authority for an additional appropriation from the CEDIT Fund. Due to the fact that there was now representation from the Building Authority Councilman Smith made a motion to table the request with a second from Councilman Moore. Carried 7-0.

Next was a request from the Council to appropriate 59.50 from the Riverboat fund. Councilman Smith made a motion to approve the request with a second from

Councilperson Hollis. Carried 7-0. Councilman Moore then made a motion to reimburse the General Fund 59.50. Councilman Vissing seconded the motion. Carried 7-0.

The Sheriff then had items tabled from the previous meeting to be appropriated in the LOIT Fund. Councilman Smith made a motion to table the request with a second from Councilman Moore. Carried 7-0.

Councilman Moore made a motion to change the regular meeting times to 7:00 p.m. beginning with the October meeting on the 11th. Councilman Abbott seconded the motion. Carried 7-0.

At this time Councilman Vissing made a motion to approve Resolution 1-2010 which approves the Mediation Settlement Agreement and the Agreed order of Judgement for the Mandate with Superior Court #2. Councilman Moore seconded the motion. Carried 6-1 with Councilman Abbott voting against the motion.

There being no further business, the meeting was adjourned.
