Regular Meeting of August 9th 2021

The regular scheduled meeting of the Clark County Council was called to order at 6:00 p.m. by Councilperson Barbara Hollis.

Those in attendance stood for the pledge of allegiance to the American Flag.

Also present were Council Attorney Maxwell McCrite, County Auditor Danny Yost, and Chief Deputy Auditor Jessica Huffman.

President Hollis requested proof of the Notice of Taxpayers of the additional appropriations listed on the agenda. Clark Council Attorney Max McCrite stated for the record that publication of the Notice of Taxpayers ran in the Evening News ten (10) days prior to this meeting as required by I.C.6-1.11-18-5 and advised the council to proceed.

Councilperson Hollis offered July 12, 2021, Regular Council minutes. Councilperson Newland motioned to approve the Regular meeting minutes of May 10, 2021. Councilperson Miller seconded. Motion carried 6-0.

Councilperson Vissing requested any amendments that need to be made to the agenda. Councilperson Newland motioned to approve the agenda with an amendment from Tri-Township Fire Protection District. Councilperson Vissing seconded. Motion carried 6-0.

Councilperson Doherty motioned to acknowledge the receipt of the fund's report provided by the Auditor's office. Councilperson Miller seconded the motion. Motion carried 6-0.

Keith Pulliam on behalf of the Tri-Township Fire Protection District presented resolution #2021-7, a request for the consent of a new public retirement system. Councilperson Miller motioned to give consent to the Tri-Township Fire Protection District for resolution #2021-7. Councilperson Doherty Seconded. Motion carried 6-0.

Councilperson Hollis relayed a message from Ruben Cummins, with Charlestown Fire Protection District, for ordinance #17-2021, an ordinance re-appropriating an additional appropriation for a new fire truck from Charlestown Fire Protection District's own funds in the amount of \$145,000.00. Councilperson Vissing motioned to approve ordinance #17-2021 for the additional appropriation in the amount of \$145,000.00 for Charlestown Fire Protection District. Councilperson Doherty seconded. Motion carried 6-0.

Jack Coffman, with the Clark County Commissioners, presented a transfer of appropriations in 1138 from the Building Improvements fund to the Lease/Bond Payment fund in the amount of \$900.00 for the lease payment on a property in Youngstown used as a center for probation. Councilperson Doherty motioned to approve the transfer of appropriations in 1138 for \$900.00. Councilperson Miller seconded. Motion carried 6-0.

Judge Vicki Carmichael, with the Circuit Courts, presented a request for additional appropriations in fund 1000 for Schools and Conferences in the amount of \$595.00, in Furniture Fixtures in the amount of \$745.00, in fund 4930 for Equipment in the amount of \$108,162.52, in fund 9128 for Supplies in the amount of \$3,182.42, in fund 8230 for Supplies in the amount of \$600.00, Travel in the amount of \$400.00, Training in the amount of \$5,000.00, Drug & Alcohol Testing in the amount of \$4,000.00, and in fund 2006 for Lease/Bond Payments in the amount of \$7,000.00. Councilperson Vissing seconded. Motion carried 6-0.

Judge Abe Navarro presented a request for three Court Reporters in the amounts of \$39,408.92, \$36,209.85, and \$35,184.90 as well as a salary ordinance for a Chief Probation Officer in the amount of \$61,063.00, and the corelating additional appropriations in fund 1000 for Personal Services in the amount of \$37,827.73, FICA/Medicare in the amount of \$2.893.82, PERF in the amount of \$4,804.12, Supplies in the amount of \$1,500.00, Training in the amount of \$100.00, Drug Screens in the amount of \$625.00, Printing in the amount of \$112.50, Dues in the amount of \$43.75, Travel in the amount of \$1,562.50, Furniture and Fixtures in the amount of \$8,780.00, and Equipment in the amount of \$500.00. Councilperson Newland seconded. Motion carried 6-0.

AN ORDINANCE OF THE CLARK COUNTY COUNCIL CONCERNING ADDITIONAL APPROPRIATIONS FOR THOSE FUNDS WHICH DO NOT REQUIRE APPROVAL OF THE DEPARTMENT OF LOCAL GOVERNMENT FINANCE ORDINANCE NO. 17-2021

WHEREAS, certain extraordinary conditions have developed since the adoption of the existing annual budget so that it is necessary to appropriate more money than was appropriated in the annual budget.

Section I. BE IT ORDAINED by the Clark County Council of Clark County, Indiana that for expenses of Clark County government and its institutions for the year ending December 31, 2021, the following sums of money are herein specified subject to the law governing the same, such sum herein appropriated shall be held to include all expenditures provided by law.

Section II. THAT for the fiscal year there is hereby appropriated out of the various funds herein for the following specified amounts to meet such extraordinary emergencies which are declared to exist.
