Minutes of the Meeting of the Clark County Drainage Board Clark County, Indiana

February 21, 2017

The Clark County Drainage Board met in Regular Session on February 21, 2017 in Room 418 of the Clark County Government Building, Jeffersonville, Indiana at 5:00pm. Present at the meeting were Vice President Jack Coffman, Member Les Kavanaugh, Ex-officio non-voting member Clark County Surveyor David Blankenbeker, attorney Bob Bottorff, non-voting advisor Clark County Engineer Brian Dixon , and secretary Talaina Taff. President Mike Killen was absent.

For the first order of business, Mr. Kavanaugh moved to accept the minutes of the January 17, 2017 meeting as submitted. Mr. Coffman seconded the motion. Motion passed unanimously.

In the next order of business, Mr. Nathan Grimes presented plans for Memphis Christian Church, 13503 Memphis-Blue Lick Road, Memphis. Upon recommendation of Mr. Dixon, Mr. Kavanaugh moved to approve the plans as submitted. Mr. Coffman seconded the motion. Motion passed unanimously.

In the next order of business, Mr. Chad McCormick presented plans for Champions Pointe Section 7, Augusta Blvd. Upon recommendation of Mr. Dixon, Mr. Kavanaugh moved to approve the plans as submitted. Mr. Coffman seconded the motion. Motion passed unanimously.

In the next order of business, **Mr. Justin Muller** presented plans for **Thorntons, Memphis.** Upon recommendation of Mr. Dixon, Mr. Kavanaugh moved to approve the plans, subject to receiving the \$1500 drainage review fee. Mr. Coffman seconded the motion. Motion passed unanimously.

In the next order of business, the Board reviewed the drainage complaint from **Bob Stidham, 2716 Sunset Trail, Charlestown.** Mr. Kavanaugh moved to allow current drainage to be directed to another drainage basin and that drainage correction be transferred to County Highway department. Mr. Coffman seconded the motion. Motion passed unanimously.

In the next order of business, the Board reviewed drainage complaints submitted by **Gerald (Pete) Hardsaw**, **9627 Hwy 60**, **Sellersburg** and **Thomas (Jack) Boyd**, **9611 Hwy 60**, **Sellersburg**. Mr. Blankenbeker gave on oral report that an obstruction(s) exists that impedes the flow of water. Mr. Kavanaugh moved to hold a hearing on March 21, 2017 regarding the obstruction of the natural surface water course. Mr. Bottorff agreed to notify involved parties. Mr. Coffman seconded the motion. Motion passed unanimously.

In the next order of business, the Board noted that drainage ordinances are complete and that Mr. Bottorff is in the process of creating form(s) for Drainage Complaint procedures.
