WHEREAS, Indiana Code § 16-22-6 et. seq., as amended (the "Act") authorizes the Board of Commissioners (the "Board") of Clark County, Indiana (the "County"), to establish, upon the written request of The Board of Trustees of Clark Memorial Hospital (the "Hospital"), a county hospital association for the purpose of financing, acquiring, constructing, renovating, equipping, and leasing to the County land and a building, including an existing building, for hospital purposes; and

WHEREAS, the Board has received a written request from the Hospital to establish a county hospital association pursuant to the Act; and

WHEREAS, the Board has previously established a county hospital association for the purposes permitted by the Act; and

WHEREAS, in order to fulfill the public purposes of the Act, the Board now desires to establish, re-establish and/or re-constitute, as appropriate, the Clark County Hospital Association.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLARK COUNTY, INDIANA, AS FOLLOWS:

Section 1. Pursuant to Indiana Code § 16-22-6-2, the Board hereby establishes, reestablishes and/or re-constitutes, as appropriate, the Clark County Hospital Association (the "Association"), a body corporate and politic, to exercise the powers set forth in the Act or otherwise granted by law. Pursuant to the Act, the Association shall be governed by a board of directors, consisting of five (5) members, to be appointed by the Board. Pursuant to the Act, the County Auditor of the County shall file a certified copy of this Resolution with the circuit court of the County.
