

**REGULAR MEETING**  
**CLARK COUNTY BOARD OF COMMISSIONERS**

September 30<sup>th</sup> 2021

The Board of County Commissioners of Clark County, Indiana met in Regular Session on September 30, 2021, at 5 p.m. in Room 418, Clark County Government Building, in Jeffersonville, Indiana.

Present at the meeting were Commissioners – Bryan Glover, and Connie Sellers, County Attorney Scott Lewis, Commissioners’ Assistant Allison Ruddell, Clark County Engineer Brian Dixon, and Auditor Danny Yost.

**Approval of the Minutes**
