ORDINANCE NO. 21 -2017

**AN ORDINANCE ESTABLISHING FEES FOR
ENHANCED GIS ACCESS SERVICES**

WHEREAS, the Board of Commissioners of Clark County, Indiana (this “Board”), is the executive body of Clark County government pursuant to the provisions of I.C. 36-2-2-2; and,

WHEREAS, the Board is also the legislative body of Clark County government pursuant to the provisions of I.C. 36-1-2-9; and,

WHEREAS, pursuant to Ordinance No. 20-2014, the Board previously established Fund Number 4964 (the “Enhanced GIS Access Services Fund” for enhanced GIS access services), whereby the purpose of the fund is for the collection of monies and fees for access to enhanced GIS services, and monies collected into the said Fund shall be expended by the Board only for the purpose of providing and maintaining GIS services; and

WHEREAS, the Board has not yet established any fees for enhanced GIS access services, and the costs of providing and maintaining GIS services has been paid for from County general funds; and

WHEREAS, I.C. 5-14-3-3.6(e) allows for a reasonable fee to be collected from a person or entity requesting enhanced access to public records; and

WHEREAS, the Board now desires to establish certain fees for enhanced GIS access services that will be used exclusively to pay for the cost of providing and maintaining enhanced GIS access services and thereby no longer requiring the use of County general funds to pay for the cost of such services; and

WHEREAS, I.C. 5-14-3-3.6 allows a public agency to enter into a contract with a third party under which the public agency provides enhanced access to the person through the third party's computer gateway or otherwise, and the Board now desires to enter into a contract with Elevate Solutions , LLC to provide such enhanced access to GIS services;

NOW, THEREFORE, BE IT ORDAINED by this Board of Clark County Commissioners as follows:

1. That pursuant to I.C. 5-14-3-3.6(e), the Board establishes the following fees for enhanced GIS access services:
 - (a) Daily subscribers will be charged a fee of \$10.00 per day (one day fee);
 - (b) Monthly subscribers will be charged a fee of \$15.00 per month (recurring monthly);
 - (c) Annual subscribers will be charged a fee of \$125.00 per year (recurring annually);
2. That basic GIS services will be provided to all users free of charge;
3. That pursuant to I.C. 5-14-3-3.6, the Board approves the contract with Elevate Solutions, LLC to provide said subscription services for enhanced GIS access services;
4. That the said fees collected for access to enhanced GIS services shall be deposited into Fund 4964 and shall only be expended for the purpose of providing and maintaining GIS services;
5. That this Ordinance shall be in full force and effect upon its passage and promulgation as evidenced by the affirmative signatures of the undersigned as the majority of the duly elected and serving members of this Board.


