First before the Council was Judge Dan Moore with a presentation on a Mental Health Program ( CIT). Judge Moore also discussed with the Council to make a part time position and full time position to help out the two Circuit Court Probation Officers.

President then opened the floor for Public Comments on the Proposed Budget. Kelly Kauri had a question on Judge Moore's request for Circuit Court.

At this time Jack Coffman and Barbara Hollis handed out a spreadsheet to explain what the budget committee came up with for the 2011 budget. The council will continue to work on the 2011 budget and the adoption date is set for October 25, 2010 at 5:00 p.m.

The inter local agreement for the Town of Covered Bridge was next before the council. Councilman Abbott made a motion to table the discussion until the October 11, 2010 meeting. Councilman Vissing seconded the motion. Carried 5-0.

Superior Court #2 Mandate payment. Councilperson Hollis made a motion to appropriate cash from the Alcohol and Drug Fund if Superior Court 2 runs short in appropriations until the judgment bond becomes available contingent upon written verification from Superior Court 3 Judge Joseph Weber. Councilman Smith seconded the motion. Carried 4-1 with Councilman Abbott voting against.

At this time Councilman Smith made a motion to have all Council Minutes posted on the County Website. Councilman Abbott seconded the motion. Carried 5-0.

There being no further business, the council adjourned the meeting.
